Hewett Primary School caters for students from R-6. At the time of this report, the enrolment in 2024 is 432. Hewett Primary School is classified as Category 6 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 4% Aboriginal students, 26% students with disabilities, 2% children/young people in care. Governing Council Report

In 2024 the Governing Council has worked diligently to support our students, staff, and families, with a broad range of representation. The Governing Council had meetings twice a term where financial reporting was provided to monitoring spending against the budget; student achievements were acknowledged, and community concerns and feedback were discussed.

The Governing Council were a proactive parent group that actively sought to further improve learning opportunities for students at Hewett Primary School by being involved in the planning and outcomes of initiatives and programs within the school.

The Governing Council were involved in:

- the continuous implementation processes and reporting of the Site Improvement Plan (SIP);
- providing support and feedback to the school to implement a range of school events including camps, excursions, Enterprise Day, Reception to Year 2 Road to Reading Evening, Sports Day, End of Year Concert and year 6 graduation;
- partnering with the Fundraising Committee's initiatives, including Ice Block Sales, Sports Day Sausage Sizzle, Mother and Father Day Stalls, School Concert, Easter Raffle and Christmas Raffle;
- providing feedback to the school regarding school events and ways to further improve them;
- the continued reduction of communication platforms across the school to streamline communication between teachers and care givers.

Our focus on student well-being and continuing achievement remains unwavering, and we are proud of the progress made during 2024. We look forward to continuing our collaborative efforts to provide the best possible education and environment for our students.

Four members completed their final tenures or retired from Governing Council. This included:


- Ms Samieko Linke retired after 6 years of membership, having been Secretary since 2019;

The Governing Council formally acknowledge these parents and their positive contribution to the school community during their tenures.


Performance Summary NAPLAN Proficiency



Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
